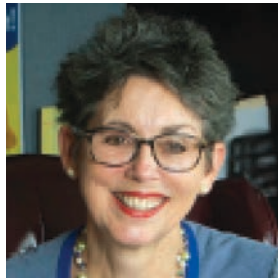

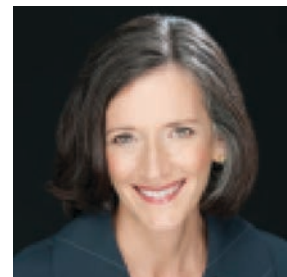

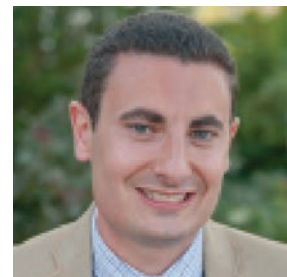

MANAGER'S UPDATE



The Borough has been strategically and incrementally expanding its communication with the residents throughout 2016. We, as many know, are on Facebook, Instagram and Twitter and we re-introduced this semi-annual newsletter. Our website was redesigned for ease of use for our residents and taxpayers. And, of course, as required by law, we advertise all public meetings and any other required activity in our newspaper of general circulation; The Times Herald.

POLICE DEPARTMENT

The Conshohocken Police Department is honored to be involved in the 2016 Fallen Heroes Wreath Program. The program was started by the family of Philadelphia Police Officer John Pawlowski (End Of Watch 02/13/2009) during the 2014 holiday season. They were inspired by the national Wreaths Across America program, and driven by the overwhelming amount of anti-police sentiment at the time. They were moved to reach out to the families of other fallen Officers. They simply wanted other families to know that their loved ones did not die in vain, and they were not going to be forgotten. No one involved in the program receives any monetary compensation. ALL assistance, from production to distribution is completely voluntary.

On December 3, 2016, members of the Conshohocken Police Department will pay respects, and lay a special wreath at the grave of Fallen Conshohocken Officer Eugene J. "Chic" Lucas. Officer Lucas was killed in the line of duty August 13, 1917 and is interred in Holy Ghost Cemetery Bethlehem PA. It is truly an honor to be involved in a program that recognizes that we will not forget the Law Enforcement Officers who made the ultimate sacrifice.

FIRE PREVENTION TIPS - PART 1

Smoke Alarms

- Install smoke alarms on every level of your home, inside bedrooms and outside sleeping areas.
- Teach your children what smoke alarms sound like and what to do when they hear one.
- Test smoke alarms once a month, if they're not working, change the batteries.
- Smoke alarms should be replaced every 10 years. Never disable smoke or carbon monoxide alarms.
- Carbon monoxide alarms are not substitutes for smoke alarms. Know the difference between the sound of smoke alarms and carbon monoxide alarms.

Fire Escape Planning

- Ensure that all household members know two ways to escape from every room of your home.
- Make sure everyone knows where to meet outside in case of fire.
- Practice escaping from your home at least twice a year and at different times of the day. Practice waking up to smoke alarms, low crawling and meeting outside. Make sure everyone knows how to call 9-1-1.
- Teach household members to **STOP, DROP and ROLL** if their clothes should catch on fire.

Cooking Safely

- Stay in the kitchen when frying, grilling or broiling food. If you leave the kitchen, even for a short period of time, turn off the stove.
- Stay in the home while simmering, baking, roasting or boiling food. Check it regularly and use a timer to remind you that food is cooking.
- Keep anything that can catch fire—like pot holders, towels, plastic and clothing—away from the stove.
- Keep pets off cooking surfaces and countertops to prevent them from knocking things onto the burner.

Caution: Carbon Monoxide Kills

- Install carbon monoxide alarms in central locations on every level of your home and outside sleeping areas.
- If the carbon monoxide alarm sounds, move quickly to a fresh air location outdoors or by an open window or door.
- Never use a generator, grill, camp stove or other gasoline, propane, natural gas or charcoal-burning devices inside a home, garage, basement, crawlspace or any partially enclosed area.

2016/2017 HOLIDAY SOLID WASTE & RECYCLE COLLECTION SCHEDULE

When a **Holiday** falls on a Saturday or a Sunday it is observed on the following Monday.

When your trash and recycle collection day falls on a holiday, your trash and recyclables will be collected on your next scheduled collection day. This is unless the holiday is on a Monday then your recyclables only will be picked-up on Tuesday.

LABOR DAY - Monday, September 5, 2016

COLUMBUS DAY - Monday, October 10, 2016

VETERANS DAY - Monday, November 11, 2016

THANKSGIVING DAY - Thursday, November 24, 2016

DAY AFTER THANKSGIVING - Friday, November 25, 2016

CHRISTMAS DAY (Observed) - Monday, December 26, 2016

NEW YEAR'S DAY 2017 (Observed) - Monday, January 2, 2017

TRASH COLLECTION RULES AND REGULATIONS

- There is a limit of 4 cans/bags per household per pick-up (200 pounds maximum)
- Each can/bag is not to be heavier than 50 pounds.
- Needles, syringes, lances and other sharp objects should be placed in a metal container with a secure lid so as not to be a hazard.
- Please place your cans/bags at curbside on your property no earlier than 5:00PM the night before. Your cans must be removed from curbside no later than 7:00PM the day of collection.
- No clean-outs or move-outs unless prearranged 24 hours in advance. Please call 610-828-1092.

- No construction debris or carpet unless prearranged 24 hours in advance. Please call 610-828-1092.
- Trash will be left curb side and 'red tagged' if deemed to be too heavy or improperly placed. Trash that is left should be returned to the property before 7:00 PM.



YARD WASTE COLLECTION RULES AND REGULATIONS:

All residences must participate in the Borough's recycling programs by separating their recyclable material from their regular trash. Yard waste is recyclable, therefore the separation and collection of this material is mandated by the Commonwealth of Pennsylvania and Conshohocken Borough.

- Grass clippings, weeds, leaves, brush and plants should be placed in biodegradable paper composting bags. Please no trash in these bags.
- Each bag should not be heavier than 50 pounds.
- Tree branches under five-(5") in diameter, not exceeding five-(5') in length, are to be securely tied into bundles and should not to be heavier than 50 pounds.
- Christmas trees. Please no decorations, tree stands or plastic tree bags.
- Please place your bags and or bundles at curbside on your property no earlier than 5:00 PM the night before.
- There is no limit of yard waste collected that is determined to be reasonable by the borough.



FALL LEAF COLLECTION RULES AND REGULATIONS:

Every year the Borough Public Works Department collects leaves beginning in October and ending in December. The schedule will be posted just prior to the start.

- The leaf pile may extend along length of your entire property. Please rake your piles to the curb but not in to the street.
- Please do not mix limbs, brush, and other debris in the leaf piles. This may result in damage to equipment and injuries to employees.
- Adverse weather conditions may cause delays on posted leaf collection dates.
- Once the leaf collecting machine passes it will NOT return.
- Leaves will not be collected in the trash. Trash with leaves commingled will not be collected.
- Motorists should obey the posted 'no parking' signs and be cautious on all roads during leaf collection season.

CHRISTMAS TREE RECYCLING

Conshohocken Borough will start recycling Christmas tree on Wednesday, December 28, 2016. Residents are asked to put their used Christmas trees on Tuesday's before the Wednesday yard waste Pick-up. Residents must remove tree bags, all ornaments, lights and stands.

The trees are collected, chipped and composted and the Borough thanks you for your cooperation.

SNOW REMOVAL

When it snows it is the Public Works goal to have all Borough and State roads clear within 6 to 10 hours after the snow has stopped falling. If you have off street parking and where ever possible please refrain from parking on the street. This will help our crews do a better job. Clear your sidewalks after plowing has been completed. A three (3) foot wide path of sidewalk must be cleared on your property within 24 hours after the snow has stopped. Don't forget your cross walks and alley crossing. It is illegal, ordinance § 21-203-205; to shovel, throw or plow snow from sidewalks, on street parking, driveways and allies into the street or right-of way. Dumping snow or ice on Borough property, or plowing snow across a street is also prohibited.



When a snow emergency has been declared by the Mayor, remember to remove your vehicle from any posted 'Snow Emergency Route'. Your vehicles must be removed until after the parking lanes have been completely cleared.

CONSHOHOCKEN IS SINGLE STREAM RECYCLING



Conshohocken's Single Stream Recycling process allows all of your recyclable materials to be placed into one recycling container. The best part is you don't have to separate them. Hence we get the term 'Single Stream Recycling'.

Residents will see trash trucks collecting your recyclables. Rest assured the recycled materials are going to the recycling facility, NOT the trash-to-steam plant.

ZONING & COMMUNITY DEVELOPMENT



CONSHOHOCKEN ZONING

Zoning is a method of regulating the built environment in a municipality. Its primary purpose is to protect the health, welfare, and wellbeing of the residents of the community. Through a “Zoning Ordinance” and a “Zoning Map”, communities determine what uses may be located in what areas of a community and how these uses must be situated on land. Zoning began in Conshohocken in 1965 with the adoption of the Borough’s first Zoning Ordinance and Map. A new Ordinance and Map were adopted in 2001 and this Ordinance currently regulates zoning in Conshohocken.

Basic zoning districts in Conshohocken are residential, commercial, limited industrial and specially planned districts. Because of the age of Conshohocken and the long term development in the Borough, Conshohocken has a significant number of “non-conforming uses”. Non-conforming uses are uses which are not permitted in a particular district, and were there when a zoning ordinance was adopted or were permitted by special exception or variance from the Zoning Hearing Board.

Conshohocken’s Zoning Hearing Board is a separate adjudicatory body appointed by the Borough Council with exclusive jurisdiction to hear and render final decisions in accord with the Municipalities Planning Code and to hear challenges and appeals by property owners. The Zoning Board is made up of five (5) individuals appointed by Conshohocken Borough Council. Zoning Board members must reside in Conshohocken, and can hold no other elected or appointed office. The Board is a quasi-judicial body which hears appeals, listens to evidence and renders decisions based on facts and law.

Between January and July, the Zoning Hearing Board has heard eleven (11) new cases and one (1) long term ongoing case. New cases have involved permitting changes in dimensions of garage sizes, the size lot on which a dwelling can be built, the size of side yards, and the placement of fences in the front yards of houses. The Board also has granted permission for the location of a day care center and a bed and breakfast in residential districts, and the establishment of a seasonal beer garden along the riverfront with conditions.

Since April of 2014 the Zoning Hearing Board has heard testimony and accepted evidence on a proposal to convert the E. F. Moore Automobile Dealership to a convenience store with gasoline sales. Comments on the proposal were heard in July, and the Board is scheduled to render its decision on the application in August with the full opinion to be released October 10th.

Notices of zoning hearings can be found on the Borough’s web site and any resident is welcome to attend hearings.

FAIR HOUSING

What It Is and What It Means For Residents Of Conshohocken



Fair housing is the guarantee that any individual, couple or family may live in any type of housing that they can financially afford in any area of a community where housing is available under conditions no different from any other individual, couple or family. Federal law, Title VIII of the Civil Right Act of 1968 and the Fair Housing Amendments Act of 1988 prohibit discrimination in housing based on race, color, religion, national origin, sex, disability, or familial status (families with children). The Pennsylvania Human Relations Act extends protection against discrimination to age (over the age of 40). Conshohocken has further expanded its non-discrimination policy to include the following groups: actual or perceived ethnicity, ancestry, gender identity or expression, sexual orientation, use of guide or support animals or mechanical aids, and/or source of income.



Some basic activities which are considered discriminatory include the following:

- Stating that housing is not available or has already been sold or rented when this is not the case
- Showing housing to a particular type of customer in only one area
- Imposing different or burdensome rental or sales terms such as higher interest rates or security deposits on one group of customers different from those required of the general public
- Advertising that a property is for adults only; mature adults are preferred, or no children are permitted
- Threaten, coerce, intimidate or interfere with anyone exercising fair housing rights

However discrimination against specific groups of individuals may take more subtle forms such as requiring a special deposit for a assistive animal, maintaining separate sections of a rental building, condominium or townhouse community for families with children;

refusing to allow reasonable modifications such as the installation of grab bars to a dwelling for a person with a disability or not returning calls from applicants for housing based the sound of their voice.

Should you have experienced anything you think may have been discrimination, there are a number of groups who can help you determine if discrimination has occurred and/or help you to file a formal complaint. These organizations include the Housing Equality Center of Pennsylvania, the Conshohocken Human Relations Commission, the Pennsylvania Human Relations Commission and the HUD Office of Fair Housing and Equal Opportunity. The Borough Administration Office (610-828-1092) can provide you with contact information for any of these groups. The Borough can also provide you with a copy of Fair Housing Guide for Consumers published by the Housing Equality Center of Pennsylvania.

Remember fair housing is your right!

DOG LICENSES AVAILABLE AT OFFICE OF MONTGOMERY COUNTY TREASURER JASON SALUS!



As you may know, Pennsylvania state law requires all dogs three (3) months or older to be licensed. A goal of the Treasurer's office is to make getting a dog license fast and easy. Licenses can be purchased or renewed online, through the mail or at a number of satellite locations across Montgomery County including the County Treasurer's office in Norristown.

If your dog is lost, a license is their ticket home. Licenses assist animal control and shelters in identifying dogs so that they may be returned home safely.

An annual dog license is \$8.50 or \$6.50 if the dog is spayed or neutered. Lifetime licenses are available for dogs that have permanent identification like a microchip or tattoo.

Additionally, older adults and people with disabilities may be eligible for discounts. Owners who do not purchase a license could face state fines and penalties of up to \$300 for each unlicensed dog.

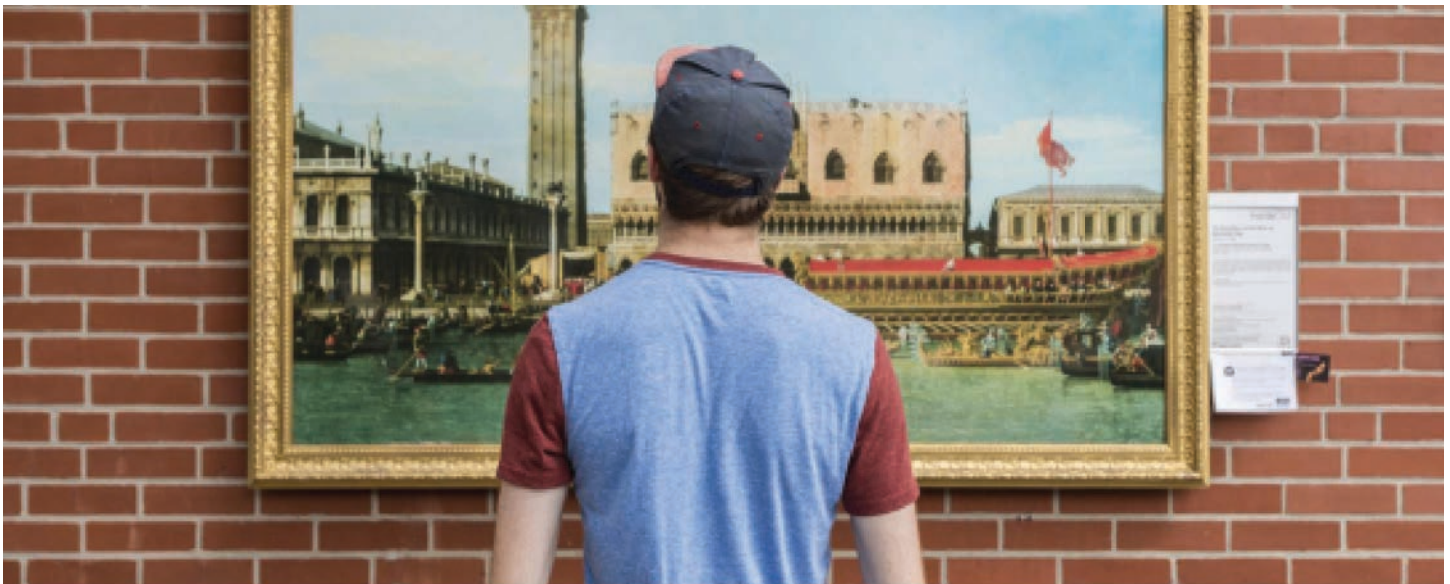

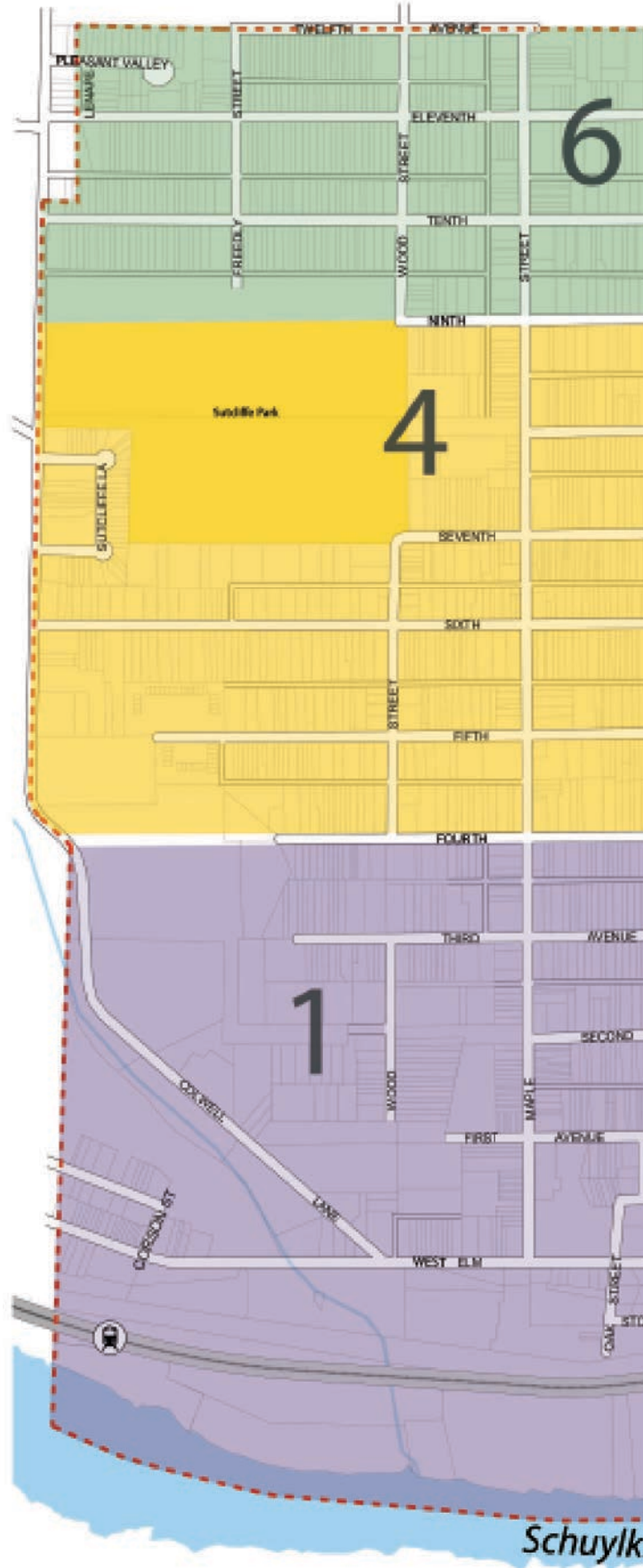

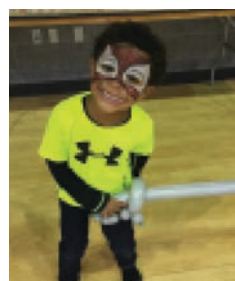

LICENSES & INSPECTIONS

The Licenses and Inspections Department work diligently to preserve and protect the health, safety and welfare of the public throughout all facets of property ownership, residency, and business operation within Conshohocken Borough. L&I is responsible to promote proactive property maintenance and regulate business activities through the issuance of permits, licenses and certificates, and conducting appropriate inspections to facilitate compliance. The Director of Engineering, Licenses & Inspections, Paul W. Hughes, PE, serves as the lead administrator for the Licenses and Inspections Department. SIDEWALK CLEARING:

The L&I staff are working tirelessly to promote proactive property maintenance to keep the public rights-of-way safe and passable for both pedestrians and motorists. The residents of and visitors to Conshohocken deserve a safe, beautiful and walkable community. Our code enforcement officers will be issuing notices to property owners with trees or other plantings encroaching on the sidewalk or street, and they will also be evaluating all the Borough's sidewalks for tripping hazards. This is a community wide effort to enhancing the pedestrian experience throughout the Borough.

BUILDING INSPECTIONS:

The Borough's building inspectors provide feedback received from permit holders for everything from small residential projects to large commercial developments. The L&I Department continues to take steps to improve the customer experience. Most importantly, the documentation and tracking associated with required inspections has been improved to ensure that all permit holders are acutely aware of the required inspections and procedures that will lead to a quick, clean and painless issuance of the permits necessary to resume or commence use of the facility. Permit holders and new applicants are encouraged to direct any questions or issues related to inspections to the Director of Engineering, Licenses and Inspections.

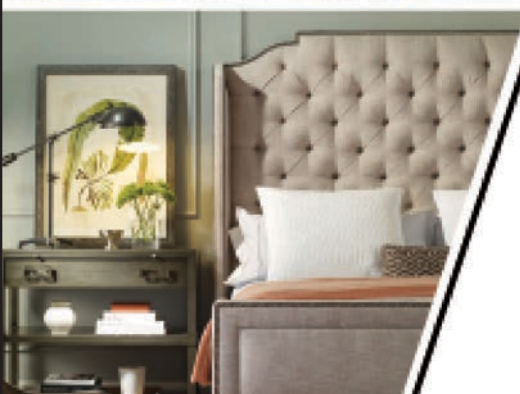
