PROCLAMATION AND DECLARATION OF LOCAL DISASTER EMERGENCY

WHEREAS, on or about March 8, 2020, the Board of Commissioners of Montgomery County, Pennsylvania signed an emergency declaration due to the outbreak of COVID-19 in the County;

WHEREAS, the Borough of Conshohocken is a Borough of the Commonwealth of Pennsylvania, operating under and pursuant to the Borough Code, 8 Pa.C.S. § 101, *et seq.*, and is located within Montgomery County;

WHEREAS, pursuant to section 10A06 the Mayor of the Borough of Conshohocken is authorized to proclaim a state of emergency where he considers that a state of emergency exists; such state of emergency shall exist for the time period set forth in the proclamation, if the state of emergency exceeds 7 days, it may be extended by resolution of Borough Council; and

WHEREAS, pursuant to section 7501 of the Emergency Management Services Code, 35 Pa.C.S. § 7501, Borough Council is authorized to declare a local disaster emergency upon finding a disaster has occurred or is imminent; and

WHEREAS, the Mayor and Borough Council have determined that, due to the COVID-19 outbreak in Montgomery County, a state of emergency exists in the Borough of Conshohocken.

NOW THEREFORE, be it proclaimed by the Mayor of the Borough of Conshohocken that a state of emergency exists within the Borough of Conshohocken. This state of emergency shall remain in effect for 7 days, or until rescinded by the Mayor. Upon ratification by Borough Council, this state of emergency shall be extended for a period of 30 days, and may be further extended by future resolution of Borough Council. During this state of emergency, the provisions of 35 Pa.C.S. § 7101, *et seq.*, shall apply.




