# CALL FOR NOMINATIONS AND ELECTION OF PRESIDENT

Mayor Frost called for nominations to elect the Council President. Ms. Barton made a motion to nominate Mr. Griffin as Council President and was seconded by Ms. Colleen Leonard. Mayor Frost called for any other nominations and none were made. All voted in favor to elect Mr. Griffin as Council President. The motion carried 6-0.

#### CALL FOR NOMINATIONS AND ELECTION OF VICE PRESIDENT

Mayor Frost called for nominations to elect the Council Vice-President. Ms. Leonard made a motion to nominate Ms. Tutino as Council Vice-President and was seconded by Ms. Barton. Mayor Frost called for any other nominations and none were made. All voted in favor to elect Ms. Tutino as Council Vice-President. The motion carried 6-0.

Mayor Frost turned the gavel over to Mr. Griffin as Council President.
