PUBLIC HEARING ON CDBG APPLICATION

Chris Stetler, Community Development and Grant Management Coordinator, shared that the Borough is eligible to receive \$153,141.00 in Community Development Block Grant (CDBG) funds through the Pennsylvania Department of Community and Economic Development (DCED). She explained that the funds must be used to benefit low- and moderate-income residents and areas of the community. Ms. Stetler explained that the purpose of the hearing is to solicit input on how the CDBG funds should be used. She reviewed program eligibility requirements. She discussed uses for CDBG funds and provided examples of projects previously funded by the CDBG grant. She also discussed requirements related to emergency work.
