# THE BOROUGH OF CONSHOHOCKEN IS CELEBRATING 175 YEARS SINCE ITS INCORPORATION IN 2025

The one square mile of land on the banks of the Schuylkill River was settled around 1820 and was named Matson's Ford after Peter Matson, a landholder before the Revolution. Around 1832, the town was laid out, and the name was changed from Matson's Ford to Conshohocken.

Conshohocken is a derivative of "Gueno Skeiki-Hacki-Ing" or "the place of the long fine land." Conshohocken was the name the Indians had for Edge Hill and could be found on deeds of purchase by William Penn on July 14, 1683, and July 30, 1685.

In 1848, the 727-resident village selected five men to represent them as the village's incorporation committee. The committee comprised James Wood, owner and manager of the J. Wood & Sons Company; Isaac Jones, president of the Matson Ford Bridge Company; James Wells, proprietor of the Ford Hotel and Railroad Depot; Cadwallader Foulke, a farmer; and David Harry, a gristmill operator who owned a large amount of the village's property.

The five men met at Norristown's Montgomery Hotel to apply for a charter to turn the village into a borough and select the new borough's name. The committee wrote three names on slips of paper and placed them into Jones' hat. The names were Riverside, Wooddale, and Conshohocken. They agreed that the third name drawn out of the hat would be the new borough's name. The final name drawn was Conshohocken.

The village would be incorporated by an act of the Pennsylvania General Assembly on May 15, 1850, thus turning it into the Borough of Conshohocken. The land for the borough came equally from Plymouth and Whitemarsh Townships.

The incorporation papers, signed by Pennsylvania Governor

William Fraeme Johnston, arrived in the newly incorporated borough via the Philadelphia, Germantown, and Norristown line on May 18, 1850.

Conshohocken would become the third Borough in Montgomery County after Norristown (1812) and Pottstown (1815).

After receiving incorporation, Conshohocken's population quickly grew, gaining over 1,000 new residents in the first decade. By 1880, the Borough's population was over six times larger than the day it was incorporated (4,561).

Today, the Borough is thriving with a robust population and a bustling downtown area on Fayette Street. It has become the home to many large corporations, including Cencora--a Fortune 100 company--Morgan Properties, Fanatics, and Aerotek.

Conshohocken is the hub for many large-scale events. The Montgomery County St. Patrick's Day Parade has marched down Fayette Street since 2006. In 2024, the Borough hosted the Simon's Heart Conshy Classic Bike Race, hosted by QCW. This June, Conshohocken will welcome the Philadelphia Flyers Alumni Bike Ride and 5/10K.

Join us as we celebrate 175 years of the Borough of Conshohocken on Saturday, May 10. We are hosting the Simon's Heart Conshy Classic presented by QCW at 1 p.m. We will have a concert on Fayette Street at Second Avenue during the bike race from 1 to 7 p.m. At 7 p.m., the festivities move to Schuylkill River where we will have food trucks, music, and a drone show that can be viewed from the Millennium II parking lot at 225 Washington Street.

# A MESSAGE FROM THE MAYOR



## An update on Thomas: Overcoming three heart surgeries

Last August, my son Thomas had a third heart surgery. During his regular cardiac check-up, one of his heart valves was found not to be closing tightly, so blood was not flowing efficiently throughout his body. While we were nervous all summer about it, he had the surgery on a Friday morning and was home by the following Thursday; truly amazing! Since this surgery, he has made incredible strides: walking, eating more foods, talking (nonstop!), and his overall complexion has improved.

He has been all over Conshohocken Borough in the last few months, from the Halloween Parade to Crab Fest at the VFW to Flocco's for a new pair of shoes! However, he still has a bit of a road ahead with one, possibly final, surgery when he turns three. The support from this community has been incredible, and Sarah and I could not be more thankful for all of the help and love of our friends and neighbors.

## Background

Thomas was diagnosed with Hypoplastic Left Heart Syndrome (HLHS) when Sarah was 20 weeks pregnant. HLHS is a severe underdevelopment of the left side of the heart and would have been fatal just a few decades ago. The Children's Hospital of Philadelphia has been at the forefront of HLHS treatment, developing a three-stage reconstruction that helps redirect blood flow, allowing Thomas and others with this disease to live with only the right side of the heart. In fact, some of our nurses at CHOP were HLHS surgery survivors!

## Getting involved

Our family was selected as a CHOP Ambassador for last year's Philly Spin-In, a major fundraiser to support the CHOP Cardiac Center. We organized a team of friends, family, and Conshohocken neighbors to ride for Thomas and all of the cardiac kids served by CHOP. The event raised over one million dollars and was packed with Conshohocken residents! # SUTCLIFFE PARK PROJECT UPDATES

## Sutcliffe Park Stormwater Project

As many residents and business owners of the Borough of Conshohocken know, the Borough is responsible for monitoring the public storm sewer system for pollutants and removing or directing to have removed any identified sources of pollution. This is part of a program known as the National Pollution Discharge Elimination System Municipal Separate Storm Sewer System (NPDES MS4). The public storm sewer system includes storm sewer inlets, piping, swales, catch basins, channels, and roads. Pollutants include soil, garbage, sewage, and nutrients found in fertilizers.

As part of the NPDES MS4, the Borough enforces a Pollution Reduction Plan to reduce the amount of sediment reaching Plymouth Creek from the public storm sewer system. The Borough met its current Pollution Reduction Plan requirements by constructing a basin under the multi-purpose field in Sutcliffe Park, reducing the amount of sediment reaching Plymouth Creek by over 12,000 pounds per year. Reducing the amount of sediment helps to improve the Creek's water quality, including for the plants and animals that rely on the Creek's ecosystem.

## Sutcliffe Park Walking Trail

Major work on the reconstruction of the Sutcliffe Park walking trail was completed at the end of 2024, and landscaping will be completed this spring. The trail provides a more level, consistently wide trail surface and rain gardens to collect stormwater runoff from the trail surface. New signage shows the overall layout of the walking trail and the connections between trails. New accessible trail connections to the park were added from West 9th Avenue and Colwell Lane. A new accessible parking space was added along Wood Street. Markers along the trail indicate the distances from the starting marker.

Reconstruction of the walking trail was supported by Borough funds, funds from the Department of Conservation and Natural Resources Bureau of Recreation and Conservation, and the Commonwealth Financing Authority Green Trails and Recreation Program.

## ZONING SERVICES

The rules for each zoning district are outlined in the Borough's Zoning Ordinance, which determines the specific land uses permitted in each district, such as residential, office, commercial, or industrial. The code also outlines the dimensional standards in each district, such as maximum building and impervious coverage, minimum building setbacks, and maximum building heights.

### **Zoning Permits:**

The Zoning Ordinance includes regulations governing off-street parking, patios, walkways, signs, fences, and accessory structures. Zoning permits are required for all of these.

The Zoning Permit application is on the Borough's website, [www.conshohockenpa.gov](http://www.conshohockenpa.gov). The permit fee is a flat fee of \$50.00, and permits require two weeks to process for completed applications.

### **Zoning Hearing Board Applications:**

The Zoning Hearing Board conducts public hearings at the request of developers and residents seeking zoning relief from a provision of the Zoning Ordinance via variance or special exception. The Board meets when an application and/or zoning petition is submitted with all applicable documentation and fees. The Zoning Hearing Board reviews applications on a case-by-case basis and makes determinations based on the Borough's Zoning Ordinance.

## HOUSING REHABILITATION PROGRAM

Conshohocken's Housing Rehabilitation Program has existed for over four decades and has assisted hundreds of Conshohocken homeowners in bringing their homes into code conformance, enabling them to live more comfortably and safely. On average, the Program completes four (4) to seven (7) properties yearly.

The Program can provide eligible single-family homeowners with numerous upgrades including, but not limited to, roof repair, window and door replacement, electrical upgrades, plumbing upgrades, kitchen upgrades, sidewalk repair, and handicap accessibility.

The Program is a four-year deferred loan program that forgives one-quarter of the loan amount each year.

If you are interested in obtaining more information about the Housing Rehabilitation Program, please contact Christine M. Stetler, the Borough's Community Development Coordinator, or Nancy R. Nugent, the Program's Intake Coordinator.

To be eligible for the Housing Rehabilitation Program, you must:

- Be below the following limits and would include salary, pension, Social Security, child support and interest on assets.

1-person household - \$64,250	5-person - \$99,100
2-person household - \$73,400	6-person - \$106,450
3-person household - \$82,000	7-person - \$113,800
4-person household - \$91,750	8-person - \$121,150



- Be a resident of the Borough of Conshohocken;
- Own and occupy a single-family residence;
- Be current in taxes and sewer fees;
- You cannot be an employee of the Borough of Conshohocken;

## Tips to Prevent Auto Theft

Police departments have seen an uptick in stolen vehicles. Most of these thefts target vehicles with the "Push to Start" feature. While we continue to try to investigate those responsible, we also wish to share some preventative tips to decrease your chance of being a victim.



- The most important thing is to always ensure your vehicles are locked. Many thefts occur because the actors find unlocked car doors.
- Know where all your key fobs are. There have been instances where people leave their main or spare keys in their vehicles, allowing the actors to gain entry to the vehicles.
- Invest in an anti-theft device. There are many options to choose from, whether it's the old-fashioned Club or a more advanced Steering Wheel Brake Lock. If used as designed, these are great tools to deter auto theft.
- Invest in a Faraday pouch or box to store your keys when you're home. These devices block the radio frequency your keys use to communicate with your car. Thieves can capture these signals while your keys are in your house.
- Place an Apple Air Tag or similar tracking device in your vehicle. While this won't stop the theft, it could lead to recovering a stolen vehicle. When putting the device in your vehicle, be sure to hide it where it will not be easily seen.
- While these are just a few easy and affordable options, we remind everyone to be vigilant. If you see any unusual activity, don't hesitate to call 9-1-1. We remind everyone not to approach anyone they believe may be engaged in criminal activity.

## Vacation Notice

If you are planning a vacation, don't forget to let the Conshohocken Police Department know about your plans.

When a resident goes on vacation, the Police Department can offer extra patrols to check on your property. This should give you some peace of mind while you're away.

Complete and submit the Vacation Notice form, which can be found online or by stopping by the Police Department. Please submit your request **at least a week prior** to your absence.

Along with notifying us of your absence, here are a few other safety measures you will want to follow.

- Notify a friend, relative, or trusted neighbor that you'll be away and leave emergency phone numbers with them in case they need to reach you.
- Be sure all your doors, windows, and gates are locked when you leave.
- Be sure to stop your mail and your deliveries or have a friend, relative, or trusted neighbor bring it in for you daily.
- Put a couple of indoor and outdoor lights on a light timer – this gives the illusion someone is home.
- Arrange for someone to take care of your lawn while you're away.

## Police Resources

Did you know that the Conshohocken Police Department has a medication drop box for unwanted or expired medications? Unwanted medications should be deposited in the labeled drop box located inside the lobby of the Conshohocken Police Station. Medication, including prescription pills and patches, over-the-counter medications, vitamins, samples, and pet medicine, are accepted. We do not accept inhalers, thermometers, needles, medications from businesses or clinics, hydrogen peroxide, ointments, lotions, liquids, or aerosol cans.



We are part of the "Blue Envelope Program," designed to aid drivers who have conditions such as Autism Spectrum Disorder, communication challenges, dementia, anxiety, or other conditions that might impair their ability to communicate easily during a traffic stop, car accident, or other driving-related interactions with police officers. Envelopes are available in our lobby.

Also available in the police lobby is a shred bin to safely and securely dispose of unwanted documents or paperwork.

The police lobby is open Monday through Friday from 8 a.m. - 4 p.m.



# FIRE SERVICES

## New Member Of The Fire Department



Meet the newest--and furriest--member of the Conshohocken Fire Department, Watson!

K9 Watson comes to us from the Penn Vet Working Dog Center in Philadelphia. He was named after Kenneth Watson, a New York City firefighter who perished in the 9/11 terrorist attacks.

He is already certified as a “live find” tracking dog with the ability to find missing persons. This spring, he will complete scent class to become certified as an ignitable liquid detection canine. These certifications will make K9 Watson and Captain Megan Klosterman only the second Arson K9 team in Montgomery County.

His talents will be used to assist the Conshohocken Fire Marshals Office as well as surrounding communities when investigating the cause and origin of fires.

The Fire Services Team works closely with Licensing & Inspections, Emergency Management, the Police Department, and Narberth Ambulance to further ensure the protection of the life and property of our citizens, visitors, and businesses. The Borough of Conshohocken employs part-time firefighters and three full-time career firefighters, who also serve as the Borough’s fire inspectors. Fire inspectors are tasked with performing annual inspections on fire alarms and fire protection systems in new and/or existing commercial buildings within the Borough of Conshohocken. State and local fire codes require that every business receive a regular fire inspection.

Fire Services for Conshohocken also consists of two volunteer fire stations, Washington Fire Company No. 1 and Conshohocken Fire Company No. 2. Both fire companies operate under station 55 and provide volunteer firefighting services to the Borough of Conshohocken.

### Home & Fire Safety

The Conshohocken Fire Department has noticed an increase in electrical house fires due to misuse of power strips. It is important to use power strips correctly. Never use multiple extension cords in one outlet. Overloading outlets, circuits, and extension cords by plugging too many things into one area can cause an electrical fire.

#### Avoid potential fires by following these safety tips below:

- Check to ensure that all electrical cords are in good condition and are not broken or cut.
- Clean the lint from your dryer after every use.
- Check to see if all plug outlets are safe and do not feel warm when you touch them. If they are warm, call an electrician.

### Free Smoke Detectors & Installation

Free smoke detectors are available to property owners and may be picked up at Borough Hall (400 Fayette Street, Suite 200, Conshohocken, PA 19428). Supplies are limited to three (3) smoke detectors per household. Residents requiring special accommodations may arrange to have their smoke detectors delivered and/or installed at no charge. Please contact the Fire Chief directly to arrange.

### Carbon Monoxide Alarms

- Install carbon monoxide alarms on each level of your home.
- Make sure carbon monoxide alarms are less than 7 years old.

### Fire Hydrant Clearance

Ensure firefighters have access to fire hydrants at any time of the year. Wintry weather can create fire safety hazards, such as ice or heavy snowfall that can obstruct fire hydrants. You can help reduce the risk by keeping fire hydrants accessible and clear of ice and snow.

### Fire Prevention Education & Events

Fire Services offers a variety of educational opportunities and events to spread awareness about fire safety. Conshohocken’s Fire Services Team provides on-site fire safety education year-round to the community at no cost. We encourage schools and businesses within the Borough of Conshohocken to contact the Fire Chief to learn more, or to schedule an on-site visit today!

Conshohocken partners with Plymouth and Whitemarsh Townships to host the annual Colonial Fire Prevention Expo. The event is held in October during Fire Prevention Week and rotates each year among the Borough of Conshohocken, Plymouth, and Whitemarsh Townships. The night is full of fun, interactive, and educational displays, including vehicle, water, and high-angle rescue demonstrations. Event information is announced on the Borough’s website under News and posted to the Borough’s social media pages.

### 2025 Holiday Solid Waste & Recycle Collection Schedule

### Trash & Recycling Cart Updates

Borough-approved containers must be used for all residential trash and recycling unless other arrangements have been made and approved by the Public Services Department. Trash and recycling cans must have two wheels, a metal lift bar, and an attached lid.

Unapproved containers will be tagged for no future pick-ups until the residence comes into compliance.



### Trash Collection Rules and Regulations

- There is a limit of four (4) cans/bags per household per pick-up (200 pounds maximum).
- Each can/bag is not to be heavier than 50 pounds.
- Needles, syringes, lances, and other sharp objects should be placed in a metal container with a secure lid so as not to be a hazard.
- Each household is permitted to dispose of one (1) large piece of furniture or bulk item per month with regular trash. This includes sofas, box springs, plastic siding, TVs, and all electronics. All other bulk trash or bulk metal collection must be arranged through the Borough of Conshohocken by calling 610-828-1092.
- Please place your cans/bags at the curb on your property no earlier than 5:00 PM the night before, and your cans must be removed from the curb no later than 7:00 PM the day of collection.
- No construction debris, carpet, clean-outs, or move-outs unless approved by the Licenses and Inspections Department. Please call 610-828-1092.

### Conshohocken Is Single Stream Recycling

Single-stream recycling allows all your recyclable materials to be placed into one recycling container. The best part is you do not have to separate them! Hence, we get the term **‘Single Stream Recycling.’** see trash trucks collecting recyclables. Rest assured, recycled materials will go to the recycling facility, NOT the trash-to-steam plant. Recycling carts should be left out before 7:00 AM on collection day, at the front edge of your property or nominated collection point.

### Yard Waste Collection Rules and Regulations

*Yard waste stickers are available at the Borough office to convert your old blue recycle bin into a container for yard waste disposal.*

All residents must participate in the Borough’s recycling programs by separating their recyclable material from their regular trash. Yard waste is recyclable; therefore, the separation and collection of this material is mandated by the Commonwealth of Pennsylvania and Conshohocken Borough.

- Weeds, leaves, brush, and plants should be placed in biodegradable paper composting bags. Please, no trash in these bags.
- Each bag should not be heavier than 50 pounds.
- Tree branches under five (5”) in diameter, not exceeding five (5’) in length, are to be securely tied into bundles and should not be heavier than 50 pounds.
- Christmas trees. No decorations, tree stands, or plastic tree bags.
- Please place your bags and/or bundles at the curb on your property no earlier than 5:00 PM the night before.



## PUBLIC SERVICES CONTINUED

### Stormwater Management

Precipitation from rain or melting snow that flows over the ground creates stormwater runoff. Surfaces like streets, driveways, and sidewalks prevent runoff from being absorbed into the ground. Stormwater runoff flows into storm drains or directly into bodies of water.

This runoff can pick up chemicals, debris, dirt, and other pollutants that will contaminate our water. It is a common misconception among residents that stormwater is treated before it reaches the waterways. This assumption is false, as everything picked up by the runoff empties into our natural waterways.

The dedicated Stormwater Management team has been actively inspecting, cleaning, and repairing storm drains and inlets since the beginning of 2024. This work allows for a healthier stormwater system and increased safety measures, such as using only bicycle-safe grates.

The repair and replacement of stormwater structures will be an ongoing task. This work will be aided by a new GIS system, which will help the team map out the underground assets and pipelines with the ability to monitor their condition. The street sweeper will also aid in this effort, as it goes out multiple times a week to clear debris from roadways that could otherwise end up clogging storm drains.

If you notice water flowing in the public storm sewer system during times of dry weather, this is a potential sign that there could be a problem. Please report any concerns to Conshohocken Borough at 610-828-1092.

## LICENSES & INSPECTIONS

Through permits, inspection, and enforcement, the Licenses & Inspections Department is responsible for the administration of Borough, State, and Federal Codes and Ordinances that pertain to Building Construction, Zoning, Land Development, Housing, and Property Maintenance.

Licenses & Inspections respond to property maintenance complaints concerning issues such as lawn maintenance and snow removal. They are also responsible for the inspections of building construction, rentals and resale, and property maintenance. Unlike other municipalities in Montgomery County, Conshohocken's Licenses & Inspections Department handles 100% of the required building construction inspections.

Licenses & Inspections works closely with the Police, Fire, and Public Services Departments to ensure the health and safety of the Borough residents.

# EMERGENCY MANAGEMENT

The Department of Emergency Management has been undergoing continued training with the County, State, and Federal Emergency Management teams to ensure preparedness for your safety in all incidents and events. This past year, this training included attendance at the Emergency Disaster Incident Training Symposium (EDITS), where staff members heard from leaders across the country who have experienced public disaster incidents firsthand. The department, which consists of members from the Police Department, Fire Department, Narberth Ambulance, Borough Administration, and Public Services, will utilize lessons learned in this training to continue updating the Borough's emergency operations plans and standard operating procedures.

The Borough of Conshohocken, in partnership with the United States Geological Survey, has added additional equipment to the Schuylkill River Flood Gauge on the Matsonford Bridge to assist in measuring the height and velocity of the river. 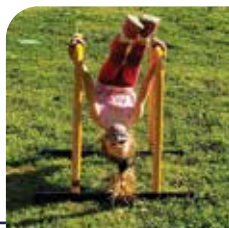

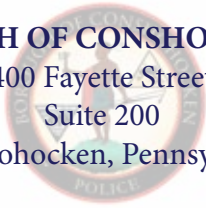
